

## POSITION DESCRIPTION

<b>Title:</b>	<b>Youth Worker</b>
<b>Award:</b>	Social, Community, Home Care and Disability
<b>Classification:</b>	Award Community Service Worker Level 2

### Position Objective:

To provide safe, supportive, and trauma-informed services to children and young people within the Permanency Support Program.

### Role Description:

To supervise, support and care for children and young people with differing needs in various settings, not limited to supervising family time, transportation, mentoring, crisis support and alternate care arrangements.

### Primary Responsibilities:

#### Values, Sanctuary and Culturally Inclusive Practice

- Commit to training in the trauma-informed Sanctuary Model and implementing this model of care in day-to-day work with young people and all members of their Care Team.
- Work in alignment with the Sanctuary Model Pillars, Anglicare's Values, and Anglicare's Code of Conduct.
- Demonstrated commitment to implementation of the Sanctuary Model.
- Advocate for the needs of Aboriginal young people and extended families in care.
- Maintain respectful relationships with stakeholders, government departments and the community to provide an integrated approach to service delivery.

#### Supporting our children and young people and their carers

- Supervise, monitor, and support family time arrangements for children and young people with their parents, family, and kin to ensure that the visits are safe and positive for children and young people.
- Transport children and young people to scheduled visits, appointments, and other regular transport requirements.

- Build caring relationships with children and young people to support their ongoing safety and developmental well-being, including promoting self-esteem, appropriate health, diet, exercise, hygiene, sexual and personal development.
- Assist young people in developing appropriate living skills in healthy meal preparation and domestic chores, e.g., washing, cleaning, gardening, and daily household management.
- Implement and maintain therapeutic approaches to support children and young people under the guidance of a Therapeutic Specialist.
- Monitor children and young people's physical, emotional, cultural, psychological, and moral safety.
- Maintain positive and therapeutic relationships with the child or young person's carers, parents, family, and kin within the young person's support networks.
- Work closely with the child or young person to act as an advocate and ensure their voice is captured in all case planning considerations.
- Understand and respond empathically to children and young people who have had prior experiences of harm, abuse, and significant adversity.
- In addition to these responsibilities and duties, you are expected to undertake other responsibilities and duties as may be assigned by Anglicare from time to time.

#### **Provide prompt and courteous service to all children and families**

- Promote a sense of belonging through engaging in meaningful, respectful, and reciprocal interactions.
- Acknowledge families as a valuable resource and develop and maintain positive relationships with them based on mutual respect and open communication.
- Model appropriate ways of interacting, speaking, and listening to children and young people during family time visits to promote parenting capacity.

#### **Administration, Supervision and Record keeping**

- To keep accurate records, files and reporting requirements consistently and clearly that meet all legislative requirements, regulations, standards and organisational policy and procedures, including but not limited to case notes, family time reports, and incident reports.
- Ensure that written records are completed and submitted within the required timeframes.
- Work in compliance with Workplace Health and Safety legislation, including reporting and investigation.
- Actively engage and participate in Sanctuary supervision with your line manager.
- Work in accordance with Anglicare's overarching operational priorities and relevant policies and procedures.
- Commitment to training and participating in professional development activities.
